

ATTENDANCE POLICY

Wandong Primary School
September 2020 – September 2024

PURPOSE

The purpose of this policy is to

- ensure all children of compulsory school age are enrolled in a registered school and attend school every day the school is open for instruction.
- ensure students, staff and parents/carers have a shared understanding of the importance of attending school.
- explain to school staff and parents the key practices and procedures Wandong Primary School has in place to support, monitor and maintain student attendance.
- record, monitor and follow up student absences.

SCOPE

This policy applies to all students at Wandong Primary School.

This policy should be read in conjunction with the Department of Education and Training's School Attendance Guidelines. It does not replace or change the obligations of Wandong Primary School parents and School Attendance Officers under legislation or the School Attendance Guidelines.

DEFINITION

Parent – includes a guardian and every person who has parental responsibility for the child, including parental responsibility under the *Family Law Act 1975* (Cth) and any person with whom a child normally or regularly resides.

POLICY

Schooling is compulsory for children and young people aged from 6 to 17 years (unless an exemption from attendance or enrolment has been granted).

Daily attendance is important for all children and young people to succeed in education and to ensure they do not fall behind both socially and developmentally. School participation maximises life opportunities for children and young people by providing them with education and support networks. School helps people to develop important skills, knowledge and values that set them up for further learning and participation in their community.

Students are expected to attend Wandong Primary School during normal school hours every day of each term unless:

- there is an approved exemption from school attendance for the student
- the student has a dual enrolment with another school and has only a partial enrolment in Wandong Primary School, or
- the student is registered for home schooling and has only a partial enrolment in Wandong Primary School for particular activities.

Both schools and parents have an important role to play in supporting students to attend school every day.

Wandong Primary School believes all students should attend school all day, every day when the school is open for instruction and is committed to working with its school community to encourage and support full school attendance.

Our school will identify individual students or cohorts who are vulnerable and whose attendance is at risk and/or declining and will work with these students and their parents to improve their attendance through a range of interventions and supports.

Students are committed to attending school every day, arriving on time and are prepared to learn. Our students are encouraged approach a teacher and seek assistance if there are any issues that are affecting their attendance.

Wandong Primary School parents are committed to ensuring their child/children attend school on time every day when instruction is offered, to communicating openly with the school and providing valid explanations for any absence.

Parents will communicate with the relevant staff at Wandong Primary School about any issues affecting their child's attendance and work in partnership with the school to address any concerns.

Parents will provide a reasonable explanation for their child's absence from school and endeavour to schedule family holidays, appointments and other activities outside of school hours.

SUPPORTING AND PROMOTING ATTENDANCE

Wandong Primary School's Student Wellbeing and Engagement Policy supports student attendance. Our school also promotes student attendance by implementing attendance celebrations and incentives at a whole school and cohort levels.

RECORDING ATTENDANCE

Wandong Primary School must record student attendance twice per day. This is necessary to:

- meet legislative requirements
- discharge Wandong Primary School's duty of care for all students

Attendance will be recorded by the classroom teacher at the start of the school day and after lunch using Compass. If students are in attendance at a school approved activity, the teacher in charge of the activity will record them as being present.

RECORDING ABSENCES

For absences where there is no exemption in place, a parent must provide an explanation on each occasion to the school. Parents should notify Wandong Primary School of absences by:

- submitting a notification via the Compass app
- contacting reception if it is an unplanned absence
- informing the classroom teacher if it is a planned absence

Wandong Primary School will keep a record of the reason given for each absence. The principal will determine if the explanation provided is a reasonable excuse for the purposes of the parent meeting their responsibilities under the Education Training Reform Act 2006 and the School Attendance Guidelines.

If Wandong Primary School considers that the parent has provided a **reasonable excuse** for their child's absence the absence will be marked as '**excused absence**'.

If the school determines that no reasonable excuse has been provided, the absence will be marked as '**unexcused absence**'. If Wandong Primary School considers that the parent has provided a reasonable excuse for their child's absence the absence will be marked as 'authorised absence' using the Compass coding system. If the school determines that no reasonable excuse has been provided, the absence will be marked as 'unauthorised absence' using the Compass coding system.

The Principal has the discretion to accept a reason given by a parent for a student's absence. The Principal will generally excuse:

- medical and dental appointments, where out of hours appointments are not possible or appropriate
- bereavement or attendance at the funeral of a relative or friend of the student
- school refusal, if a plan is in place with the parent to address causes and support the student's return to school
- cultural observance if the parent/carer notifies the school in advance
- family holidays where the parent notifies the school in advance

If no explanation is provided by the parent within 10 school days of an absence, it will be recorded as an 'unexplained absence' and recorded on the student's file. Parents will be notified if an absence has not been excused.

MANAGING NON-ATTENDANCE AND SUPPORTING STUDENT ENGAGEMENT

Wandong Primary school will follow a staged response to non-attendance. This process is outlined in greater detail below:

Stage 1 - First day of absence

Automated SMS sent to parent/s via Compass at 10am.

Purpose: To alert the parent there is an unapproved absence.

Stage 2- Second day of consecutive absence, and each subsequent absence until child returns to school.

Class teacher phones parent via telephone. If no answer, leave a message or send email for parent to call the school to discuss the child's absence. Record actions on Compass.

Purpose: To ascertain reason of absence and to find out when student will return.

Stage 3- Four days absence in any one term- Notify Leadership to determine an appropriate course of action.

Stage 3 letter/email sent to parent/guardian regarding absences.

Purpose: To communicate specific concerns of student absences and to highlight the fact that if attendance doesn't improve, an Attendance SSG will need to be held and possible referral to the Education Department's Student Attendance Officer.

Stage 4- No improvement of attendance

Attendance Student Support Group (SSG) meeting required. Parent, teacher, the student (where appropriate) and a member of leadership attend.

Purpose: To avoid the absences becoming 'chronic' (20 days per year) by focusing on:

- Identifying the reasons for the student absences.
- Positive and proactive solutions.
- Ensuring all members are aware of the absences and understand the educational implications for the student.
- Working collaboratively to develop strategies to support the student's attendance, via a Student Attendance Improvement Plan.

MANAGING NON ENGAGEMENT AND STUDENT ATTENDANCE

Where absences are of concern due to their nature or frequency, or where a student has been absent for more than five days, Wandong Primary School will work collaboratively with parents, the student, and other professionals, where appropriate, to develop strategies to improve attendance, including:

- establishing an Attendance Student Support Group
- implementing a Return to School Plan
- implementing an Individual Education Plan
- implementing a Student Absence Learning Plan for students who will be absent for an extended period
- arranging for assistance from relevant wellbeing staff

We understand from time to time that some students will need additional supports and assistance, and in collaboration with the student and their family, will endeavour to provide this support when it is required.

REFERRAL TO SCHOOL ATTENDANCE OFFICER

If Wandong Primary School decides that it has exhausted strategies for addressing a student's unsatisfactory attendance, we may, in accordance with the School Attendance Guidelines refer the non-attendance to a School Attendance Officer in the North for further action.

If, from multiple attempts to contact with a parent, it becomes apparent that a student will not be returning to the school, the principal may make a referral to a School Attendance Officer if:

the student has been absent from school on at least five full days in the previous 12 months where:

- the parent has not provided a reasonable excuse for these absences; and
- measures to improve the student's attendance have been undertaken and have been unsuccessful
- the student's whereabouts are unknown and:
- the student has been absent for 10 consecutive school days; or
- no alternative education destination can be found for the student.
